O R D E R

Learned counsel for the appellant wants time to file an affidavit indicating the present status of the vacancies from 1996 to 2008 in reference to the Civil Services examination and may also take instructions in regard to the present status of the writ petition filed by the respondent before the High Court of Delhi and any other dispute, if any, pending in reference to the grievance which has been made before this Court.

Learned counsel for the respondent is directed to place on record the copy of the writ petition filed before the High Court.

Office Memorandum (OM) dated 27.09.2022 has been placed for our perusal which is taken on record. We consider appropriate to observe that the appellant shall hence forthwith may comply the said OM for all selection processes to be held in future.

We further make it clear that the rules in terms of OM dated 27.09.2022 shall stand amended and necessary amendments may be made by the appellant in this regard and be notified.

Heard learned counsel for the intervenor.

We find no reason to entertain the instant application for intervention. Accordingly, I.A. No. 120625/2022 for intervention is rejected.

The applicant(s) is at liberty to place on record the Office Memorandum (OM) dated 27.09.2022 before the High Court where the proceedings are pending and agitate his grievances.

All other contentions are open.

Let the affidavit be filed within four weeks.

Upon filing of the documents, the parties are at liberty to mention the matter.
